

**LENOVO OLYMPIC TORCH AND THEMED NOTEBOOK PC SWEEPS
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. THIS CONTEST IS ONLY OPEN TO LEGAL RESIDENTS OF THE UNITED STATES (EXCLUDING RESIDENTS OF PUERTO RICO) WHO ARE 18 YEARS OLD OR OLDER.

ELEGIBILITY: All applicable federal, state and local laws and regulations apply. The Lenovo Olympic Torch and Themed Notebook PC Sweeps (the "Promotion") is open only to legal residents of the United States and the District of Columbia (excluding residents of Puerto Rico) who are at least 18 years of age at the time of entry. By entering this Contest, submitters give their express permission to be contacted by Sponsor by telephone, e-mail and/or postal mail on matters related to the "Promotion" entry. Submitters must provide valid e-mail and postal addresses. Entries will be declared made by the authorized account holder of the e-mail address submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to the e-mail address by an Internet access provider, online service provider, or other organization (e.g. business, educational institution, etc.) which is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Proof of being the authorized account holder may be required. Entries must be submitted by 11:59:59 PM EDT on September 30, 2008. Limit one entry per person for the entire Promotion Period.
